## **Sewer Lateral Repair Policy**

On April 4, 2000, voters of the City of Calverton Park approved a proposition to assess a \$28.00 fee, per year, on all residential property containing not more than six dwelling units to provide funds to pay the cost of certain repairs of defective lateral sewer service lines serving such dwellings, accordingly, the following is adopted as policy of the City of Calverton Park for such sewer lateral repair:

- 1. Effective June 23, 2014, the owner of a single family, may recover up to four thousand dollars (\$4,000.00) of such owners costs in repairing defective lateral sewer service lines serving the property of the owner. In compliance with the City's policy as set forth herein.
- 2. If a owner is experiencing a problem with the lateral sewer line, the owner shall contact a plumbing company or a drain and sewer cleaning company to have the line cabled. The video must be provided to the City for review. The cost of cleaning out the sewer line will not be a reimbursable item.
- If it is determined that the service line is defective, the owner must obtain at least three bids for the work to ensure that the contractor has given a fair and competitive bid. All bids must be submitted to the City for review and approval.
- 4. Once approval has been obtained, the owner may hire the selected contractor to perform the corrective work. Contractor must obtain the necessary excavation permits from the City of Calverton Park and plumbing permits from St. Louis County before work begins.
- 5. It is the responsibility of the property owner to ensure the contractor is properly licensed and insured.
- The City does not guarantee the performance of any contractor and will not be responsible for any damage caused to property by the sewer lateral defect or the actions of the contractor or any subsequent failure of the work performed.
- 7. The corrective work is limited to excavation, repair or replacement of the line, backfilling, seeding and strawing of the disturbed portion of the yard.
- 8. The owner shall be responsible for the cost of removing or restoring any portion of any deck, porch, patio, planter box or other structure which plumbing contractor deems necessary to allow replacement of a sanitary sewer lateral.
- 9. Persons who wish to participate in the sewer lateral repair program shall complete an application on forms provided by the City of Calverton Park.
- 10. Applicants for the sewer lateral repair program at the time of making application shall certify applicant's acknowledgement that the City of Calverton Park is not responsible for the acts by the contractor making the sewer lateral repairs and that applicant shall indemnify the City of Calverton Park and hold harmless from any and all claims arising out of the applicant's participation in and work performed and actions taken in connection with the sewer lateral program.

- 11. Upon completion of the corrective work, the owner shall contact the City for a final inspection. The contractor may submit an invoice to the City of Calverton Park to be forwarded to the Board of Aldermen for approval.
- 12. Emergency work will be dealt with on an individual case by case basis.
- 13. Administration of the sewer lateral repair program shall be contingent upon the availability of funding collected or anticipated to be collected pursuant to the \$28.00 yearly fee approved by the voters.
